I will make no claim for any funds that may accrue to the San Angelo Symphony Society, its assignees or licensees, resulting from the use of photographs, and recorded, filmed, or/videotaped materials. I further grant permission for the use of my submitted photograph and biography in all media, including brochures, magazines, newspapers, electronic transmission, and on the Internet.
